

THE RURAL MUNICIPALITY OF DUNDURN NO. 314
A BYLAW TO SET THE RATES FOR WASTE WATER UTILITY SERVICES
BYLAW NO. 04-15

The Council of the Rural Municipality of Dundurn No. 314 in the Province of Saskatchewan enacts as follows:


1. Accounts for Utility Services will be set as a monthly rate and will be billed quarterly in each year.
2. The charges to be paid by the ratepayer shall be those set out in Schedule "A" attached.
3. Property owners (Exempt Property) with a private sewage system that was installed prior to the Dundurn Waste Water Utility system and listed on Schedule "B" are exempt from the monthly service fee unless they begin using the pipeline in the future.
4. Lots owned by the Developer of each subdivision will be charged a rate separate from the privately owned lots and will be set on Schedule "A" attached.
5. A penalty of 1% per month will be added to all utility accounts outstanding in the next billing quarter.
6. The rates on Schedule "A" will be reviewed by council and updated as necessary.
7. The rates and charges contained in this bylaw shall come into force and take effect on the day of approval being issued by the Local Government Committee or September 1, 2015, whichever is the latter.
